# Meeting Minutes Regular Board Meeting July 24, 2017

#### I. Call to order

### III. Approval of minutes from last meeting

## IV. Correspondence

Angela Beehler, District Manager, presented an email received from Chase Freeman, a resident asking for assistance with an Eagle Scout project involving restoration of a City of Richland wetland that has become overgrown with vegetation. He was redirected to the Benton County Noxious Weed Control District Manager, but it's possible mosquito control could provide some assistance in the future.

#### V. Manager's Report

- a) WNv Activity: the lab has tested 239 mosquito samples with six of those coming back positive from the Grandview area.
- b) The District participated in the El Rancho Reata community event on July 8<sup>th</sup>. The West Umatilla Mosquito Control District allowed us to borrow their education trailer for the event.
- c) Aerial spraying was conducted on July 11<sup>th</sup> and is scheduled for July 28<sup>th</sup> due to high numbers of adult mosquitoes.
- d) Angela is working with the City of West Richland and the Noxious Weed Control Board to reduce Phragmites in the Paul Keith wetland in order to increase the efficacy of larviciding.
